IMSA On the onset of the meeting, Chairman Professor Khare welcomed the members and congratulated everybody for the registration of the Association, and also appreciated the efforts made by a few of the members who worked tirelessly and successfully made it possible. Then the Chairman apprised the members of the proposal for publishing a Journal named "International Journal of the Indian Mathematics and Science Association" (Hereafter to be referred to IJIMSA), and forming its Editorial Board(s).

Professor Pandey, Convener of the meeting, initiated the discussion by floating the proposal of three Sections of the proposed Journal with distinct Editorial Boards in order to maintain standard and do justice to different disciplines to be covered for publication. He also added that it was Professor Khare who had opined this in a personal conversation. It was whole heartedly welcomed by the members, and after at length discussions and deliberations, it was unanimously resolved that

- 1. There be three sections for the journal IJIMSA, namely, A/Mathematical Sciences, B/ Physical Sciences, and C/Biological Sciences.
- 2. Mathematical Sciences may cover Mathematics, Statistics, Data Sciences, Computer Science, Economics, Management, Engineering Sciences, and Mathematical Modelling.
- 3. Physical Sciences may cover Physics, Chemistry, Geology, Engineering Sciences and all sciences except Biology.
- 4. Biological Sciences may cover Zoology, Botany, Medical Science, Biotechnology, Biomedical Engg, Biochemical Engg, Environmental Sciences, and all other life sciences.
- 5. Distinct sections need to have independent Editorial Boards including Editor-in-Chief. Accordingly, such subcommittees to form distinct Editorial Boards be constituted.
- 6. Members of the concerned Sections may be authorised to form the respective Editorial Boards. They may, however, consult members of other Sections for interdisciplinary areas or areas having interfaces.
- 7. The next meeting may be scheduled in 15 days to review the progress, and decide the next course of action.
